ITEM NO. 10. PROCUREMENT SKID MOUNTED WATER STORAGE RECTANGULAR TANK FOR FIRE FIGHTING – QTY = 04 NOS 55KL capacity rectangular water storage tank of size: Length-9000mm; Width-2500mm; Height-2450mm mounted on oil field type skid of ISMB-250. The body of the tank should be made out of 6.0mm MS corrugated sheets with roof made out of 6.0mm MS chequered plate suitably welded on structure and complete with manhole, cleaning door, ladder, water inlet & outlet connection and other accessories. However the bidder must have to provide the detail drawing with dimensions, material, accessories, arrangement, corrugated sheet design etc for technical scrutiny. A. 1.0 Dimension of the Tank: Each tank should have following dimensions: i. Length: 9000mm [excluding 300mm skid extension on each end for tail boarding] ii. Breadth: 2500mm iii. Height: 2450mm 1.1 Tank Wall & Roof: All 4(four) walls of the tank are to be constructed with 6.0mm thick MS corrugated plates and bottom portion is to be constructed with 6.0mm thick plain plate. The bottom of the tank should be sloped gradually to maximum 75.0 mm towards the tank clean out gate at the rear side for proper tank cleaning purpose. Roof of the tank should be covered & constructed with 6.0mm thick MS chequered plates. The covered top should have 2(two) covered manholes & 1(one)ladder inside the tank in one of the manholes. 1.2 Master Skid: The tank should be mounted on 3(three) runner oilfield type skid fabricated out of ISMB-250 beams reinforced with suitable channels and angles. The ends of the skid should be projected out from the tank by 300mm and curved upwards. 150mm NB X 80 SCH pipe with provision for lifting should reinforce the end of skid for tail boarding. 1.3 Tank Connections: i. There should be 100mm (4") NB ANSI B 16.5 screwed NPT flange welded one each at the front of the tank & at the back of the tank for outlet & cleanout purpose. ii. There should be 1(one) 50mm NB X 150mm long screwed NPT nipple welded at the back side of the tank body 50mm (2") below the top of the tank for water overflow.	

1.6 Tank Railings:

The top of the tank should be provided with foldable safe guard railings made of SHS of size 32 mm x 32 mm and 3.2 mm thickness conforming to IS:4923 and IS:1161 with toe boards made of 3mm thick MS plates welded to the bottom of the railings.

1.4 Material Specification:

Material for fabrication of tanks should be as follows:

- i. Beam, Channel, Angle, Plate etc.: as per IS-2062
- ii. Tail Boarding Pipe: ASTM-A106 Gr.B-Sch80
- iii. Square hollow section: As per IS:4923 and IS:1161 having a YST 310 grade.

1.5 Welding Procedure:

All welding procedure should be followed as per standard norms & done by certified welder. All welding electrodes should be as per IS: 814. There should be minimum 3(three) layers of welding & all welds should be visually inspected / examined. The critical welds should be subjected to radiography test, magnetic particle test and dye penetration test. Necessary test certificate must be shown at the time of inspection & provided along with dispatch documents.

B.1.0 Surface Preparation:

After completion of all fabrication jobs, the surface preparation should be carried as follows:

- i. All welds should be made free of slag, slag inclusion, pinholes, spatters etc. Scrapping & Wire brushing should be carried out on all steelworks after removing all oil & grease deposit if any using approved degreasing agent & solvent.
- ii. Blast cleaning should be carried out in a controlled blasting shop & not during inclement weather conditions.
- iii. The air used during blast cleaning & after cleaning should be dry & free from moisture & all oil contamination.
- iv. All blast cleaned surfaces should be coated with the prescribed primer within 4(four) hours of blasting.

1.1 Painting:

a. Outside Surface & Skid:

- i. 2(two) coat of zinc primer of 70-80 micron DFT should be applied all over the outside surface & skid of the tank.
- ii. 2(two) coats of Synthetic Enamel paint (Berger, ICI, Nerolac, Shalimar) of 90-100 DFT of Signal Red colour should be applied on the outer tank wall surface, ladder, connections etc.
- iii. 2(two) coats of synthetic enamel paint of Black colour should be applied on the Skid of the tank.

b. Inside Surface:

- i. 2(two) coat of Epoxy primer of 70-80 micron DFT should be applied all over the inside surface of the tank.
- ii. 2(two) coats of Epoxy paint (Berger, ICI, Nerolac, Shalimar) of 90-100 DFT should be applied on the inner tank wall surface.

C. 1.0 Inspection of Tank:

Each tank should be offered for inspection to OIL with at least 2 weeks in advance of the following stages:

- i. Any time between completion of entire fabrication job & ready for hydraulic testing.
All the tanks should be hydraulically tested for 24hrs & this will be witnessed by the OIL's representative during the inspection.
Surface preparation followed by painting should be started after successful hydraulic testing & getting clearance from the OIL's inspector.

ii. Any time between blasting / painting & prior to dispatch. Tanks will be allowed for dispatch after getting clearance from the OIL's inspector. D. 1.0 Accessories: i. All the tanks should be provided with strongly built sturdy ladder with hand railings: one ladder in one of the manholes for entering the tank & one at the rear end of the tank. ii. The inlet water feed line should be provided with 100mm (4") ASTM-A106 Gr.B- Sch40 pipe & shall be anchored firmly with the rear wall of the tank.

Special Notes:

- i. Bidder must provide detail design & drawing of the tank offered along with dimensions, accessories, connections, material specifications, corrugated sheets design etc to meet OIL's NIT requirement.
