Warranty: 5 years comprehensive onsite.

## **Special Notes:**

### A) General Conditions:

- 1. Bidders must be the OEM or authorized dealer/distributor of OEM and documentary evidence in this regard is to be submitted along with the bid.
- 2. Bidders other than OEM must submit valid <u>dealership/authorization certificate from the OEM</u> against the tender along with their offer, failing which the offer shall be <u>rejected</u>.
