- b) Necessary Login ID & Password will be issued by OIL only after submitting the complete online registration by the Bidder. In the event of late registration/incomplete registration by Bidder, OIL INDIA LIMITED shall not be responsible for late allotment of User ID & Password and request for bid closing date extension on that plea shall not be entertained by Company.
- c) The bidder claiming as MSE status (MSE-General, MSE-SC/ST, MSE Woman) against this tender has to submit valid "Udyam Registration No" (URN) as per Gazette notification no CG-DL-E-26062020-220191 dated 26.06.2020 issued by MINISTRY OF MICRO, SMALL AND MEDIUM ENTERPRISES. ### 4. DESIGN FEATURES:

### A. PUMP:

- a) Submersible Water Pump Set should be a compact unit made up of a submersible pump and a submersible motor coupled either with spline type or square type male-female connector/coupling and operates submerged beneath the surface of water.

All power and control connections in the panel should be done with Copper conductors only. The panel should be supported on a rigid frame so that bottom edge of the panel is at least 300 mm above floor, for easy and safe entry of power and control cables. The frame should be able to withstand stress and vibration during transportation. All cables/wires to be bottom entry. All indication lights, Meters and displays shall be located on the front. The front shall be open type, with a rain protection canopy on the top. The panel should be made from 3 mm thick MS CRCA sheet and built upon a rigid framework with fitting lugs on top and ventilation louvers on both sides. The panel should have bottom detachable gland plates and earthing studs on two sides. The metal surface of the panel should be given suiable anti-corrosive treatment and the painted. The panel design and manufacture should be as per IS 8623.

### 5. SPECIAL INSTRUCTION:

### A) MECHANICAL:
