### FLOW CUM PRESSURE CHART RECORDERS FOR VARIOUS OIL INSTALLATIONS. – QTY = 03 NOS

- 1. Pressure Range: 0-3 Kg/cm2
- 2. Differential Pressure Range: 0-100 inch of WC
- 3. Application: Natural Gas Pressure and Flow Measurement
- 4. Process Connection: ½" NPT (F), separate for static and differential pressure
- 5. Suitable for process Temperature range: 0-70 Degree Centigrade
- 6. Mounting Provision: Slip-on non-thread pipe mounting suitable for 2 inch(OD) pipe with arrangement to secure the mounting
- 7. Pressure measuring element: Precision wound helical type Bourdon element, Material 316SS.
- 8. Differential Pressure Measuring element: Liquid fill Dual bellows assembly made of 316SS. ### 9. Recorder system:

- a) It will be a two pens system, one pen for static pressure and other for differential pressure to record permanently on a circular chart. The recording system will be so designed that mechanical movement of the primary pressure sensing elements will be converted into a linear movement of the pens on the circular chart
- b) All line/link should be adjustable
- c) Will be with micrometre adjustment facility for zero, range and linearity calibration
- d) All parts of the recording mechanism will be made of stainless steel
- e) Chart drive will be modular spring wound chart drive, Minimum 7day wind
- f) Chart Speed: One revolution per day
- g) Accuracy:  $\pm\,0.5\%$  of full scale for differential pressure,  $\pm\,1\%$  of

full scale for static pressure or better

- h) Along with other parts, the system will have pen lifter to lift the pens during chart change, chart plate, chart clip to hold the chart, over range stop, pen mounting arrangement
- i) The system should be suitable for Circular chart with marking for differential (square root) and static pressure (linear)of printable area of minimum of 10 inch diameter.
- 10. Case: Made of die-cast Aluminium alloy and are finished in black polyurethane electrostatic powder paint with high resistance to weathering, scratches, marring and industrial
