iv) Performance Security:

The successful bidder shall submit Performance Security @ 10% of Purchase Order value within 30 days of receipt of the formal purchase order failing which OIL reserves the right to cancel the order and forfeit the Bid Security. Bidders should undertake in their bids to submit Performance Security as stated above.

The Performance Security shall be in any one of the following forms :
