### SPECIAL NOTES

1.Bidder other than Manufacturer must submit the valid authorization /dealership certificate from the Manufacturer along with the offer.

2.During bid submission,Bidder should provide his consent to comply all the following points .

2.1.The Conductor material should be of stranded compacted H2/H4 grade Aluminum (Class 2)as per IS:8130–1984 with latest amendments, provided with Conductor Screening of extruded semi-conducting cross link material.The allowable operating temperatures of the conductor screen /shield shall be equal to or greater than those of the insulation.

2.2.The Conductor Screen & XLPE Insulation shall be extruded in the same operation as per IS:7098(Part-II)with latest amendment /revision. The interface between the extruded conductor screen and insulation shall be free of any voids.

2.3.No tolerance on the negative side shall be acceptable for insulation thickness w.r.t IS:7098(Part-II)with latest amendment /revision.

2.4.Extruded Semi-conducting screening over the insulation of each core and metallic screening of copper tape shall be applied as per IS: 7098 (Part-II) with latest amendments. The semiconducting compound shall be suitable for the operating temperature of the cable and compatible with

the insulating material. The interface between the insulation and insulation screen shall be free of any voids. Insulation screen shall be strippable type.

2.5.The metallic screen shall consist of a layer of copper tape applied in helical form applied over the insulation screen to carry the fault current.

2.6.In three core cables, the cores shall be laid together with a suitable right hand lay. The interstices shall be filled with non-hygrosopic material.

2.7.The laid up cores shall be provided with inner sheath applied by extrusion process only.No tolerance on the negative side shall be acceptable for thickness of the inner sheath w.r.t IS: 7098 (Part - II) with latest amendments.

2.8.The armouring shall be of galvanized flat steel strip as per IS:3975 with latest amendments.No tolerance on the negative side shall be acceptable.

2.9.The outer sheath shall be of PVC compound conforming to the requirements of type ST 2 compound of IS :5831 with latest amendment /revision and applied by extrusion as per IS:-7098 with latest amendment /revision.

2.10.The cable shall be supplied in continuous standard length of 500 running meters wound on non returnable wooden drums of good quality .No negative tolerance is acceptable .

2.11.The both ends of the cables shall be sealed by means of non-hydrosopic sealing materials. In absence of the same materials will not be acceptable .

2.12.The Bidders should submit the copy of valid BIS License of the Manufacturer certifying the approval of the product at least up to the tender opening date.If applied for renewal, the copy of receipt of fees and or acknowledgement of BIS shall be furnished with copy of BIS License (Expired)along with the offer.

2.13.The copy of Technical Datasheets(with all relevant lectrical/physical parameters) & Type Test Certificates as per IS :7098(Part-II)amended upto date shall be submitted along with the bid.

2.14.The Type Test Certificates shall not be more than Five years old from the bid opening date.

2.15.All the Routine Tests as per IS :7098(Part-II)amended upto date shall be carried out on each and every delivery length of cable.In addition Acceptance Test as per IS :7098(Part-II)shall also be carried out from the offered cable lot.

2.16.Routine & Acceptance Tests will be carried out at the works of manufacturer's in presence of OIL's representative only. Materials shall be dispatched by the supplier only after successful Routine & Acceptance Test.The copy of Test Reports shall also be submitted anlong with the materials delivery.

2.17.The vendor shall have to inform min 15 days in advance to OIL for witnessing the Routine & Acceptance Test.

2.18.Progressive running length of the cable shall be marked on outer sheath at an interval of not more than 10 Mtrs.
