2.1.The Conductor material should be of high conductivity annealed plain Copper confirming to IS-8130(with latest amendment /revision).

2.2.The XLPE insulation over the conductor shall be applied by extrusion as per IS:7098(with latest amendment /revision).

2.3.The outer sheath shall be of PVC compound conforming to the requirements of type ST 2 compound of IS :5831 (with latest amendment /revision) and applied by extrusion as per IS:-7098(with latest amendment /revision).

2.4.Cable shall be supplied in single length of 1000 Metre . (deviation up to  $\pm 5\%$  of length shall be acceptable). Non-standard length will not be acceptable.

2.5.The ends of the cables shall be sealed by means of non-hydroscopic sealing materials.In absence of the same materials will not be acceptable .

2.6.The Bidders should submit the copy of valid BIS License of the Manufacturer certifying the approval of the product at least up to the tender opening date.If applied for renewal,the copy of receipt of fees and or acknowledgement of BIS shall be furnished with copy of BIS License (Expired)along with the offer.

2.7.The copy of Technical Datasheets(with all relevant electrical/physical parameters) & Type Test Certificates as per IS :7098 amended upto date shall be submitted along with the bid.

2.8.The Type Test Certificates shall not be more than Five years old from the bid opening date.

2.9.All the Routine Tests as per IS :7098 amended upto date shall be carried out on each and every delivery length of cable.In addition Acceptance Test as per IS :7098 shall also be carried out from the offered cable lot of all the sizes.
