- 3.0 For obtaining User ID and Password for accessing the tender document and for submission of bids, interested bidders are requested to go for Online Registration. Bidders are advised to apply for user ID and password at least 7(seven) days prior to the last date of tender fee payment for their own interests. User ID's shall be processed within 4(four) days subject to submission of complete information by the bidder. Once the registration is completed user id and password will be assigned to the bidder. - 3.1 After completion of the Online Registration process and receipt of user id and password, bidder may submit the tender fee online (Non-refundable). F. TEST AND INSPECTION:

- a) All routine tests shall be carried out as per relevant IS and IEC.
- b) The equipment shall be inspected by engineer(s) of OIL prior to dispatch. Prior intimation at least 15 days in advance to be given to OIL for inspection before dispatch. Routine tests in accordance with relevant IS shall be carried out at manufacture's works which shall be witnessed by OIL's engineer(s). The inspection shall include accuracy of dimensions & circuitry as per approved drawings, insulation tests, mechanical & electrical operation tests, primary current injection tests and any other test of the relays as recommended by the manufacturer. All necessary arrangements for the tests shall be made by the supplier at their works during the inspection. All to & fro charges, boarding /lodging of OIL Engineers shall be borne by OIL. Bidder not to include the same in their quote.
- c) Any alteration requirements pointed during the inspection shall be carried out by the manufacturer and confirmed before dispatch, without which dispatch clearance shall not be given.
- d) Copies of the test certificates along with bound copies of complete test results shall be submitted for approval of OIL prior to dispatch of the PCC. This shall include complete reports and results of the routine tests as also certified copies of the type tests.

G. WARRANTY:

The equipment shall be of best quality and workmanship. The Panel along with all electrical equipment shall be guaranteed for 12 (Twelve) months from the date of commissioning against defects arising due to material, workmanship or design.

H. INSTALLATION AND COMMISIONING OF PANEL

- 1. Installation, Testing & Commissioning of PANEL -
 - (i) Shall be carried out under direct supervision of Specialist engineer from PANEL manufacturer.
 - (ii) Tools and tackle shall be provided by bidder for erection, testing and commissioning.
 - (iii) IR value of the panel shall be checked before energizing. Earth resistance value shall also be checked before energizing of Panel.
 - (iv) Earthing: Earthing of the LT Panel including installation of 2(two) numbers of chemical earth electrodes and interconnection with 50mm × 6mm GI Strip shall be in the scope of bidder. All the materials required for earthing shall be brought by the bidder. The individual electrode resistance to earth should be less than 5 ohm and grid resistance less than 1 ohm.
- 2. Bidder shall arrange for to & fro travel to the installation site, local conveyance and boarding & lodging during the installation. All charges shall be borne by the bidder and should be quoted accordingly separately which shall be inclusive of GST and all other taxes including Income Tax/Corporate Tax/ Personal Tax to be deducted at source.

BID REJECTION CRITERIA/ BID EVALUATION CRITERIA

I. <u>BID REJECTION CRITERIA (BRC):</u>

The bids must conform to the specifications, terms and conditions given in the tender document. Bids shall be rejected in case the items offered do not conform to the required minimum/ maximum parameters stipulated in the technical specifications and to the respective international /national standards wherever stipulated.

Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the offer/ offers will be considered as non-responsive and is/are liable to be rejected, if the following conditions are not fulfilled:

(A) TECHNICAL

- 1.0 The bidder must quote for both (a) supply and (b) installation and commissioning of Panel.
- 2.0 The Bidder shall be the manufacturer of LT Panel or their authorised dealer. In case the bidder is an authorized dealer, they must submit Dealership/Authorization Certificate from the Original Manufacturer which shall be valid till completion of order as per the bid document.
- 3.0 <u>In case the Bidder is an OEM</u> The Bidder shall have experience of design, manufacture and supply of at least 1 sets of LT Panel to any Central Govt. / State Govt. / PSUs /Public Limited Companies in the last 5(five) years prior to the original bid closing date of the tender.
- 4.0 <u>In case the Bidder is an Authorised Dealer</u> The Bidder shall have experience of supply, installation & commissioning of at least 1 sets of 415V PCC Panel/ PMCC Panel/MCC Panel, of the same Manufacturer whose item has been quoted in the tender, to any Central Govt./ State Govt. / PSUs /Public Limited Companies in the last 5(five) years prior to the original bid closing date of the tender
- 5.0 Bidder shall submit documentary evidences such as purchase order and completion certificate of relevant previous supplies or Tax Invoice or Payment Certificate or Consignee receipted delivery challan or Performance Certificate and other necessary details & documents along with offer for meeting clause no. 2.0, 3.0 and 4.0 above.
- 6.0 One manufacturer can quote only through one supplier.
- 7.0 One supplier can quote based on an authority letter from one manufacturer only.
- 8.0 The bid shall be rejected, in case of any change of the manufacturer after submission of bid.
- 9.0 A job/supply executed by a bidder for its own organization/subsidiary cannot be considered as experience for the purpose of meeting Bid Rejection Criteria/ Bid Evaluation Criteria.

- 13.1 The bids conforming to the specifications, terms and conditions stipulated in the enquiry and considered to be responsive after subjecting to the Bid Rejection Criteria will be considered for further evaluation as per the Bid Evaluation Criteria given below:
 - 1. Basic Material Value
 - 2. Packing & Forwarding Charges, if any
 - 3. Total Ex-works Value (1+2)
 - 4. GST on Total Ex-Works Value
 - 5. Compensatory Cess, if any
 - 6. Total FOR Despatching Station Value (3+4+5)
 - 7. Freight Charges upto destination
 - 8. GST on Freight Charges
 - 9. Insurance Charges @0.5% of (6) inclusive of GST
 - 10. Installation & Commissioning Charges
 - 11. GST on Installation & Commissioning Charges
 - 12. Total FOR Destination, Site Value (6+7+8+9+10+11)
- 13.2 Comparison of offers shall be done on Total Value vide Srl. No. 12 (Total FOR Destination Value).

- 13.3 Domestic bidders must quote inland freight charges upto Destination. In case bidder fails to quote inland freight charges, highest freight quoted by domestic bidder (considering pro-rata distance) against this tender or OIL's estimated freight, whichever is higher, shall be loaded to their offer for comparison purpose.
- 13.4 If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
- 13.5 Other terms and conditions of the enquiry shall be as per General Terms and Conditions for LCB Tender. However, if any of the Clauses of the Bid Rejection Criteria / Bid Evaluation Criteria (BEC/BRC) mentioned here contradict the Clauses in the General Terms & Conditions of LCB Tender of the tender and/or elsewhere, those mentioned in this BEC/BRC shall prevail.
