# 1. **SCOPE:**

Design, Supply & Installation of Resistive Load Bank of 800 KW along with its Breaker Panel & Remote Operating Control Panel & arrangement required for proper cooling including supply of the following:

## 2. INCOMER:

ACB, 3Phase, 1600A, 50KA, for 1 sec, CT for each Phase, MFM, Numerical relay (Panel Incomer) for protection with over current earth fault under voltage (Similar to ref615 ABB incomer relay)

#### 3. **OUTGOING:**

Fuse-100A for each step and additional requirement, 95A Contactor for resistive load for each step, Individual Starter for Cooling Mechanisms, Control Transformer-1No.

#### 4. SITE CONDITION:

I. Ambient Temperature : Max 50°C, Min 10°CII. Relative Humidity : 95% approx.

# 5. DATASHEET FOR LOAD BANK:

I. Duty : Suitable for Continuous operation

# 7. SPECIFICATION OF ACB:

I. Type : Indoor, horizontal isolation, horizontal draw out type.

II. Mounting : In cassette type enclosure

III. Insulation Medium : Air.IV. Rated operational voltage of CB : 415 VV. Rated insulation voltage : 1000 V.

VI. System Earthing : Effectively earthed.

VII. No of poles : Three.
VIII. Rated frequency : 50 Hz
IX. Rated current : 1600A

X. Rated making current : 125 kA or higherXI. Rated short time withstand capacity : 50 kA for 1 sec at 415 V

XII. Ultimate rated breaking capacity : 50 kA at 415 V

XIII. Spring Charging : Motorized as well as manual.

XIV. Method of closing : Through closing coil as well as Manual.

XV. Control Supply : 230 V AC XVI. Closing coil voltage : 230 V AC

XVII. <u>Method of tripping</u>:

a) Shunt trip coil voltage: 230 V ACb) Manual with mechanical trip button.

XVIII. Mechanical indication:

a) Breaker ON/OFF

b) Position SERVICE/TEST/ISOLATED

XIX. Protection Type: Separate tripping mechanism (relay) to be provided with the ACB

XX. The circuit breaker shall conform to latest edition of IS 13947 except where specified otherwise in the specification.

- XXI. Main contact material shall be of copper alloy with silver facing and shall have ample contact area and contact pressure for carrying rated normal / short time currents and shall be adequate to keep temperature rise within limits.
- XXII. Working parts of operating mechanism shall be of corrosion resisting materials. Bearings, which require grease, shall be equipped with pressure type grease fittings. Bearings, pins, bolts, nuts etc. shall be adequately pinned or locked to prevent loosening or changing adjustments with repeated operation of the breaker. The outside parts of the breakers and ferrous parts such as hangers, supports, bolts and nuts shall preferably be hot dip galvanized or zinc plated.
- XXIII. The ACBs shall be supplied complete with enclosures as may be necessary. The enclosure shall not be liable to distortion and misalignment.
- XXIV. The formed and welded steel construction shall be given corrosion resistant treatment following fabrication work. The enclosure / cubicle and doors shall be finished with stove enamel paint.
- XXV. The breakers shall have three distinct positions SERVICE/ TEST/ ISOLATED, within the cubicle and this shall be achieved by suitable racking cam and slide rails system operated from the front of the equipment. Visual indicators shall be provided to show these three positions.
- XXVI. A STOP shall be provided on the guide rails to prevent accidental falling of the breaker while withdrawing the moving portion.
- XXVII. SAFETY SHUTTER ASSEMBLY shall be provided for shrouding of the main contacts when the breaker is withdrawn. This must operate automatically during insertion and withdrawal of the circuit breakers.
- XXVIII. Operating Mechanism:
  - a) There shall be provision for manual as well as motorized spring charging. Closing shall be through 230 V AC closing coil. Provision for manually closing the breaker shall also be there. It shall be ensured for each breaker that it closes at the correct speed.
  - b) A direct mechanical coupling shall give indication of ACB #ON# or #OFF#.
  - c) A shunt release shall be provided for electrical tripping of the breaker.
  - d) Supplier shall ensure correct wiring to facilitate tripping of the breaker.

# XXIX. Interlocks:

- a) The breaker cannot be closed in any intermediate position other than three distinct positions #SERVICE/TEST/ISOLATED.
- b) The front door / cover cannot be opened when the circuit breaker is in closed condition.
- c) The moving portion of the breaker shall be earthed before the main circuit breaker controls are plugged in the stationary contacts i.e. before the control circuit is completed. Positive earthing of the circuit breaker shall be maintained in the connected position.
- d) Anti-pumping feature shall be provided for each breaker.

## 8. REMOTE CONTROL PANEL:

Remote Control Panel should have the provision of Switching Operation (ON/OFF) for each step of load, display of real time load (Amps & KW), ON/OFF indication Status of each step of load bank, Real time temperature of load bank at multiple locations (min. 4 no's using RTD) with an alarm in case the temperature exceeds a set value. The same to be installed at GEG Control Room.

#### 9. **COOLING:**

Suitable Cooling Arrangement to be provided for safe and continuous operation of Load Bank in all weather conditions. The cooling arrangement thus provided to be suitable for continuous operation and with sufficient redundancy.

- 10. The load bank has to be remotely operated and integrated with HT panel of existing GEG. Bidder has to take assistance/co-ordination from the supplier of GEG M/s Greenpower prior to supply of Load Bank for understanding any integration issues that may arise during commissioning and accordingly resolve the same.
- 11. Interconnection drawings and Control circuits between Load Bank, Transformer, HT Panel to be submitted along with the bid for owner's consent.
- 12. Tools and tackle shall be arranged by supplier/vendor required for successful erection, testing and commissioning.
- 13. IR value of the panel shall be checked before energizing.
- 14. Scope also includes Transportation to site, Unloading at Site and Erection & Installation of the same over the foundation. **Unloading at site and Erection & Installation to be provided on "free of cost" basis.**

# 17. TEST AND INSPECTION:

- I. The load bank shall be inspected by OIL engineer at manufacturer's work prior to dispatch.
- II. Visual and Dimensional checks to be done.
- III. Resistance Measurement within tolerance ±10% using digital Ohmmeter.
- IV. Insulation Resistance measurement using megger.
- V. High Voltage withstand test as per IEEE-32 standard.
- VI. Heat Run Test on Resistor:
  - Heat run test will be conducted by passing rated/ equivalent current for rated/ equivalent time through part of the resistor (not through the complete unit) and temperature rise will be measured by digital thermometer.
- VII. The supplier shall give 15 days advance intimation to OIL regarding inspection for deputing Engineer.
- 17.1 All expenses (Lodging & Transportation) towards inspection by OIL Engineer will be borne by OIL, however all arrangements required for successful testing & inspection at Manufacturer's works shall be under Bidder's Scope.

## 18. WARRANTY:

The equipment shall be of best quality and workmanship. The load bank with all electrical equipments shall be guaranteed for 12 (Twelve) months from the date of commissioning or 18 (Eighteen) months from the date of supply, whichever is earlier, against any defects arising due to material, workmanship or design.

- (ii) Bidder shall submit Cable Schedule, SLD, Control Wiring Drawing and any other technical details as required along with the bid.

## 20.1 **PAYMENT TERMS**: Payment terms shall be as under –

Against Supply: (i) 70% against receipt of materials at site.

(ii) 30% against completion of Erection & installation & Commissioning.

Against supervision: 100% payment shall be released on pro-rata basis.

# 21. SUPERVISION OF COMMISSIONING OF 800 KW (LT) RESISTIVE LOAD BANK

- (i) Bidder shall provide service for supervision during commissioning of the entire Load Bank System. <u>Bidder shall quote per diem rate for the same</u>. The per diem rate shall include to & fro charges, local conveyance charges, lodging & boarding, all insurances including Bidder's personnel and third party insurance, all other incidental charges and all taxes & duties except GST which shall be quoted extra and shall be payable against submission of Invoice as per prevailing GST rules. <u>No other charges shall be payable except for the per diem charges and GST on per diem charges.</u>
- (ii) Tax(s) as per Government policy shall be deducted at source by OIL while making payments against each invoice.
- (iii) Per diem charges shall be payable from the day bidder's person reaches site upto the day he leaves the site. No payment will be made for travel days/period.
- (iv) Vendor's personnel shall observe/abide by site working conditions prevailing at the existing site, safety codes, Indian laws and local laws.
- (v) 30 Man days shall be considered for the purpose of evaluation.
- (vi) Personnel for supervision of commissioning shall be deputed within 10 days of advance intimation by OIL.

#### **BID REJECTION CRITERIA/BID EVALUATION CRITERIA**

#### I. BID REJECTION CRITERIA (BRC):

The bids shall conform generally to the specifications, terms & conditions given in this bids document. Notwithstanding the general conformity of the bids to the stipulated specifications, the following requirements will have to be particularly met by the bidders without which the same shall be considered as non -responsive and rejected.

## (A) TECHNICAL

- 1.0 The bidder shall be the original equipment manufacturer(OEM) or the bidder shall have valid dealership/authorisation certificate from the original equipment manufacturer, the documentary evidence of which shall be furnished with the quotation. The Certificate shall remain valid for the entire tenure till the completion of the order.
- 2.0 The bidder (Original equipment manufacturer (OEM) or Authorised dealer/supplier), they shall have experience of successfully completing one job of Supply, Installation & Commissioning of 800 KW Load Bank in previous 05 (five) years reckoned from the original bid closing date. The supplied load bank shall be under satisfactory operation for at least 01 (one) year as on original bid closing date.

For proof of above requisite experience, self-attested photocopies of following documents must be submitted along with the bid:

Completion/ Performance Certificate from the end user mentioning the following details:

- a) Capacity of Load Bank
- b) Details of Supplier
- c) Commissioning Date
- d) Performance of Load Bank
- 2.1 Additional documentary evidence for clause 2.0 above must be provided along with the bid in the form of purchase order or payment certificate or Tax Invoice from the user/owner, failing which offer will be rejected. The documentary evidence shall be for supply to PSUs/Central Govt. / State Govt. Organization /Oil Refining or gas processing Company (Working under jurisdiction of OISD–Oil Industry Safety Directorate).
- 3.0 In case the bidder is an authorised dealer/supplier of the original equipment manufacturer (OEM), the bidder shall have experience as referred in clause no. 2.0 for the same item of the OEM as offered in the tender.
- 4.0 One manufacturer can quote only through one supplier/authorised dealer.
- 5.0 One supplier/authorised dealer can quote based on the authority letter from one manufacturer only. Bid shall be rejected in case of any change of manufacturer after submission of bid.
- 6.0 A job/supply executed by a bidder for its own organization/subsidiary cannot be considered as experience for the purpose of meeting Bid Rejection Criteria/ Bid Evaluation Criteria.

# 7.0 <u>DELIVERY PERIOD:</u>

- (i) Delivery shall be completed within 4(Four) months from the date of issue of Purchase Order.
- (ii) Erection and Installation shall be completed within 2(Two) weeks from the date of site readiness. Date of site readiness shall be intimated 1(One) week in advance.

#### (B) FINANCIAL:

- 1.0 Annual Financial Turnover of the bidder during any of preceding three financial/accounting years from the original bid closing date should be at least INR 20,75,000.00
- 1.1 **Net worth** of bidder must be positive for preceding financial/ accounting year.
- 2.0 Considering the time required for preparation of Financial Statements, if the last date of preceding financial/accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial/accounting year are not available with the bidder, then the financial turnover of the previous three financial/accounting years excluding the preceding financial/accounting year will be considered.
