- 3.0 Bidders without having E-tender Login ID and Password should complete their online registration at least 7(seven) days prior to the scheduled bid closing date and time of the tender. For online registration, Bidder may visit the OIL's E-tender site https://etender.srm.oilindia.in/irj/portal.

BID REJECTION CRITERIA/BID EVALUATION CRITERIA

I. BID REJECTION CRITERIA (BRC):

The bids must conform to the specifications, terms and conditions given in the tender document. Bids shall be rejected in case the items offered do not conform to the required minimum/ maximum parameters stipulated in the technical specifications and to the respective international /national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the offer/ offers will be considered as non-responsive and is/are liable to be rejected, if the following conditions are not fulfilled:

(A) TECHNICAL

1.0 The Bidder shall be the manufacturer of LT Cable (1100V Grade) or their authorized dealer/distributor.

2.0 In case the Bidder is an OEM

- 2.1 The Bidder shall have experience of designed, manufacture and supply of at least 1000 M of 3.5 core 240mm² PVCA Aluminium Cable to any Central Govt. / State Govt. / PSUs /Public Limited Companies in a single order in the last 5(five) years to be reckoned from the original bid closing date.
- 2.2 Documentary evidence in support of having experience as per 2.1 must be submitted in the form of purchase order and completion certificate or payment certificate or Tax Invoice or consignee receipted delivery challan or any other documents which substantiate successful execution of each of the purchase order along with the bid failing which offer will be rejected.

Note: The Purchase Order date need not be within 5 (five) years preceding original bid closing date of this tender. However, the execution of supply should be within 5 (five) years preceding original bid closing date of this tender.

3.0 In case the Bidder is an Authorised Dealer/Distributor

- 3.1 The bidder must submit valid Dealership/ Authorization certificate along with the offer which shall be valid till the tenure of the PO.
- 3.2 The Bidder shall have experience of supply of at least 1000 M of 3.5 core 240mm² PVCA Aluminium Cable to any Central Govt. / State Govt. / PSUs /Public Limited Companies of the same make as offered in the bid in a single order in the last five years to be reckoned from the original bid closing date.

- 4.0 Bidder has to submit valid BIS certificate & Type test certificate from NABL accredited test laboratory along with the offer.

- 6.0 One manufacturer can quote only through one supplier/authorised dealer.
