



1. "Materials must be inspected and certified by any one of the OIL authorized third party inspection agencies viz. M/s. BV / IRS / Lloyds / RITES / DNV / Tubescope Vetco prior to despatch. - (iii) For bends, Elbows and other forged fittings: Materials are to be heat treated properly before machining. Necessary heat treatment graph chart and certificate to be produced at the time of inspection.
- (iv) One/two piece(s) against each heat treated lot and size after formation and before machining will be selected and stamped by Inspector for physical and chemical testing. For Bend below 2", Butt Weld Elbow & Tee below 4", Swadge Nipple and Butt Weld Reducer, physical testing (only hardness) and chemical testing will be carried out. Physical testing of the materials at Govt. Approved Laboratories/ OIL approved Laboratories will be witnessed and certified by Inspector.
- (v) Dimensional check (min. 15% of offered quantity) will be done as per the relevant standard/ specification/ OIL approved drawings by Inspector and it must be certified by them.
- (vi) All the threads must be gauges and checked as per relevant original master gauges and certified by Inspector.
