- 1.0 General Qualification Criteria:
  - In addition to the general BRC/BEC, following criteria on Bidders' Experience and their financial capabilities shall be considered (documentary evidence to be provided along with the bid in Technical RFx -> External Area > Tender Documents as on the Bid Closing Date:
  - a) Bidder should have experience of successful execution of at least one similar order for Rs. 7.18 lakhs during last 3 (three) years as on bid closing date to companies under the Government, Semi Government, Public sector undertakings or Public Limited Companies.

- b) Average Annual financial turnover during the last three years, ending 31<sup>st</sup> March of the previous financial year should not be less than Rs 23.93 Lakhs.

- 4.0 Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the NIT or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in rejection of its offer without seeking any clarifications.
- 5.0 All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) with organisation name as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.

- 6.0 Bidders must ensure that their bid is uploaded in the system before the tender closing date and time. Also, they must ensure that above documents which are to be submitted in a sealed envelope are also submitted at the above mentioned address before the bid closing date and time failing which the offer shall be rejected.
- 7.0 Bid must be submitted electronically only through OIL's e-procurement portal. Bid submitted in any other form will be rejected.
- 8.0 The tender shall be governed by the Bid Rejection & Bid Evaluation Criteria given in enclosed Annexure-II. Markings: Name plate details with name of manufacturer, frame size, rated voltage,

rated output, current, frequency, type of duty, class of insulation, no.of phases, speed in rpm at rated output, degree of protection, winding connections, amb temp, bearing sizes, lubricant, lubrication material and

year of manufacture.

Paint : Two coats of DA grey paint.

Make : Bharat Bijlee/Crompton Greaves/KEC/Siemens/NGEF

# General Notes on motor:

Motor shall be tested as per BIS and test certificates shall be furnished with the supply.

Starter: The motor shall be supplied along with a starter as specified below:-

- 1. The starter shall be suitably designed for the application and HP rating of the pump.
- 2. The starter shall have:
  - a) Power contactor(s), AC3 duty, as necessary depending on type of starter (01 no. for DOL; 03 nos for YD starter), with 4NC + 4NO auxiliary contacts.

    Make: Siemens/L&T/Telemechanique (Schneider). AC3 current rating of the contactors shall be 30% higher than the AC3 current rating recommended in contactor selection chart of Siemens/L&T/Telemechanique (Schneider).
  - b) The starter shall include START/STOP push button with terminals for remote Start/ Stop PB Station.
  - c) Protections; nThe motor shall have the following minimum (but not limited to) protections in the starter panel
    - i) Overload (make of OLR shall be same as that of contactor).
    - ii) Phase failure(make of SPPR: Siemens Telemechanique(Schneider).
  - d) Suitable cable entry arrangement for terminating the incoming / outgoing cables.

## Remote Push Button Station:

A remote weatherproof type Start / Stop Push Button Station having suitable cable entry arrangement with gland plate and single compression heavy duty nickel plated brass gland, for terminating the cables shall be supplied with each motor.

Make of PBS: Siemens, L&T, Telemechanique Schneider), BCH, Crompton.

- C. THE MOTOR AND THE COMPRESSOR SHOULD BE MOUNTED ON A COMMON SKID. BELT GAURD SHOULD BE PROVIDED. THE MOTOR AND THE COMPRESSOR SHOULD BE SUPPLIED IN A UNITISED CONDITION.
- D. Suitable flexible coupling is to be provided to directly couple the motor with air compressor. Technical details and make of the coupling should be provided along with quotation and drawings.

#### Documents:

- 1. Bidder shall furnish every detail of the electrical items in their offer as per above in the same order. All of the above shall form part of the order. Hence any deviations must be clearly mentioned which shall be scrutinize for acceptability. Specific type and make of components should be mentioned clearly. No deviation shall be allowed at the time of supply and in such case the order will be cancelled without any liability to OIL. IN CASE OF SUCH CANCELLATION OIL MAY RECOVER FROM THE BIDDER THE COST INCURRED BY OIL IN PROCESSING THE TENDER TILL THE TIME OF CANCELLATION.
- 2. All electrical items shall be procured from OEM or their authorized dealers only. In case of dealers copies of valid certificates shall be furnished with the offer, without which the offers shall not be considered for evaluation
- 3. The following documents shall be submitted with the offer.
- i) GA and dimensional drawing of all electrical equipment.
- ii) Technical details of the motor.
- iii) Bill of materials with technical details of various components of the starter and PBS.
- 4. The successful bidder shall obtain approval for the drawings prior to manufacturing of equipment / panel
- i) GA and dimensional drawing of all equipment
- ii) Power and control circuit diagrams with BOM

The manufacture of the unit is to be started only after written approval of the drawings by OIL.

- 5. Four bound sets of the following documents, shall be submitted with the supply
- i) Approved GA and dimensional drawing of all equipment.
- ii) Approved power and control circuit diagrams.
- iii) Technical details of the motor.
- iv) Bill of materials with technical details of various components of the starter and PBS.
- v) List of recommended spares for two years.
- vi) All test certificates.

#### **Transportation:**

During transportation all electrical equipment are to be suitably packed to avoid water ingress or transit damage.

Note: Air compressor AND Motor should be compact design and in one skid. THEY SHOULD BE SUPPLIED IN UNITISED CONDITION. BELT GAURD IS TO BE PROVIDED.

# **Special terms and conditions:**

- i) Safety valve is to be provided in the air receiver and shall be so constructed & adjusted as to permit the Air to escape from the air receiver without increasing the system pressure beyond 10% above the Working pressure when the air compressor are giving full output and all outlets other than safety valve or valves are closed.
- ii) Safety valve shall be designed such a way that they cannot be inadvertently over loaded beyond the pressure at which they have been adjusted.

- iii) A drain valve or cock shall be provided either for manual operation at a point for enabling the draining of the condensate.
- iv) Suitable Air flow regulator / controller (ball valve, butterfly valve etc) shall be fitted with the delivery piping.
- v) Analog gauges for pressure (unit in kg/sq.cm or in PSI) and temperature (degree Centigrade and Degree Fahrenheit) must be provided. All gauges must be of reputed make like MURPHY, FISCHER, DANIEL or equivalent reputed make.
- vi)The Air receiver must be hydraulically tested at a pressure range of 1.5 times of the maximum delivery pressure of the Screw Air Compressor and the certificate of testing is to be provided along with the supply.
- vii)The bidder must undertake and confirm from OEM that the equipment to be supplied are not going to become obsolete for the next 10 years and provisioning of spares will be continued.
- viii) Bidder has to provide 3 sets of instruction and operation manual, parts catalogue, drawing etc along with the supply of materials for both compressor and motor.
- ix) Materials must be guaranteed for fabrication, workmanship and performance for a period of 18 months from the date of despatch or 12 months from the date of commissioning whichever is earlier and relevant guarantee certificates have to be provided along with the bill/ despatch documents.
- x) The bidder shall specify the tests and inspection procedures that may be necessary to ensure that materials are satisfactory for the service. Such test shall have to be mentioned in the bidder's offer. The bidder shall have to submit detail test certificates for the material testing (Material of Construction)mentioned in their offer prior to predispatch inspection of the air compressor.
- xi) Any special tools required for maintenance of air compressor should be supplied along with the air compressor and should be included in the offer with unit price, part no etc.
- xii) Spare parts book with part no (3 sets) for each motor, compressor and any other consumable parts of the unit should be furnished along with the supply, in case of an order.
- xiii) Successful bidder should emboss the OIL's respective Order No on the air compressor Body.

# xiv) Inspection & Test Certificates

Compressor sets shall be inspected and load tested at manufacturer's works/factory prior to dispatch. However, such inspection will not relieve the supplier of his responsibility to ensure that the compressor sets supplied confirms to the correct specifications and is free from manufacturing and all other defects.

Intimation must be sent to OIL at least 28 days in advance for inspecting the compressor sets at manufacturer's premise. The supplier shall submit details records and test

certificates for prime mover and air compressor along with delivery of the air compressor sets

- xv) Two years maintenance spares is to be supplied along with the materials, these spares should be separately packed with waterproof material and separately marked.
- xvi) Technical literature/brochure from the OEM of both compressor and motor is to be submitted along with the bid. The technical literature/brochure must conform to required minimum / maximum parameters stipulated in the technical specifications.

# BID REJECTION CRITERIA (BRC) / BID EVALUATION CRITERIA (BEC)

The following BRC/BEC will govern the evaluation of the bids received against this tender. Bids that do not comply with stipulated BRC/BEC in full will be treated as non responsive and such bids shall prima-facie be rejected. Bid evaluation will be done only for those bids that pass through the "Bid Rejection Criteria" as stipulated in this document.

Other terms and conditions of the enquiry shall be as per General Terms and Conditions vide MM/CALCUTTA/E-01/2010 for E-Procurement LCB Tenders. However, if any of the Clauses of the Bid Rejection Criteria / Bid Evaluation Criteria (BRC / BEC) contradict the Clauses of the tender or MM/CALCUTTA/E-01/2010 elsewhere, those in the BRC / BEC shall prevail.

# **BID REJECTION CRITERIA (BRC):**

The bids shall conform generally to the specifications and terms as well as conditions laid out in the tender. Bids will be rejected in case the items offered do not conform to the required parameters stipulated in the technical specifications and to the respective international/national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be met by the bids, without which, the same shall be considered as non-responsive and stand rejected.

# A - TECHNICAL

- 1. Bidder must be an OEM or authorised dealer of OEM either for compressor or motor. If the bidder is OEM/authorised dealer of compressor, he should purchase motor from OEM / authorised dealer of motor vice versa. Valid authorised / dealership certificate must be submitted along with the quotation.
- 2. The bidder should have experience of successfully executing at least one similar order for Rs 7.18 lacs during last 03 years as on bid closing date to companies under the Government, Semi Government, Public sector undertakings or Public Limited companies. Documentary evidence as per following note must be submitted along with the offer, failing which the offer will be rejected.

Note:

- i) Similar Order means Order means Purchase Order for supplying of Air Compressor of rating 1 HP or above in Govt/Semi-Govt. organizations, PSU & Public Limited Company.
- ii) In case the bidder submits documentary evidences of more than one Purchase Order in support of the bid, then the total value of the Purchase Orders should be at least Rs 7.18 lakhs during the last three years as on the Bid Closing Date of the tender.
- iii) The bidder must submit the followings as documentary evidence (attested/self attested) in support of the experience:
- (a) For OIL Purchase Order, copy of "Purchase Order" of completed supply must be submitted as per BRC Clause 2. above
- (b) For supply to other Govt/Semi Govt/PSU or Public Limited Company, copy (s) of Purchase Order of the supply along with invoice against the purchase order or Completion certificate of the supply from the end user are/ is to be submitted. In case the bidder submit Completion certificate from the end user, the completion certificate should clearly mention the Purchase Order No(s), Total Value of Supply and complete description of the supplied item.

#### 2.0 FINANCIAL:

- 2.1 The Annual financial turnover of the firm in any of the last 03 financial years or current financial year should not be less than Rs 23.93 lacs. In support of annual financial turnover, any one of the following documents/photocopies (self attested/attested) must be submitted along with the bid:
- ► A certificate issued by a practicing chartered/cost accountants firm with membership no. certifying the annual turnover and nature of business.
- Audited balance sheet and profit & loss account.

# **B: COMMERCIAL**

- i) Bids are invited under **Single Stage Composite Bid System**. Bidders shall quote accordingly under Single Stage Composite Bid System.
- ii) Bid security in the form of Demand Draft / Bank Guarantee as per format given in the LCB booklet MM/CALCUTTA/E-01/2010 of Rs 24,000.00 shall be submitted manually in sealed envelope superscribed with BID SECURITY AGAINST Tender no. SKI9221P16 dated 12.11.2015 to Head Calcutta Branch, Oil India Limited, 4 India Exchange Place, Kolkata - 700001 only on or before the Bid Closing Date and Time mentioned in the Tender. If security **ORIGINAL** of above mentioned in amount is not received within bid closing date, the bid submitted through electronic form will be rejected without any further consideration.

In lieu, Bid Security of **Rs. 24,000.00** can also be paid online through our eprocurement portal as per procedure given in user manual in OIL's eprocurement portal. For exemption for submission of Bid Security, please refer relevant para of General Terms and Conditions vide MM/CALCUTTA/E-01/2010 for E-Procurement LCB Tenders.

The Bid Security shall be valid for 180 days more than the Bid validity, i.e., for 300 days from the date of bid opening.

- iii) Bidders must confirm that Goods, materials or plant(s) to be supplied shall be new of recent make and of the best quality and workmanship and shall be guaranteed for a period of twelve months from the date of successful commissioning against any defects arising from faulty materials, workmanship or design. Defective goods/materials or parts rejected by OIL shall be replaced immediately by the supplier at the supplier's expenses and no extra cost to OIL.
- iv) The prices offered will have to be firm through delivery and not subject to variation on any account. A bid submitted with an adjustable price will be treated as non-responsive and rejected.
- v) Successful bidder will be required to furnish a **Performance Bank Guarantee** @10% of the order value. For exemption for submission of Performance Bank Guarantee, please refer relevant para of General Terms and Conditions vide MM / CALCUTTA / E-01 / 2010 for E Procurement LCB Tenders. The Performance Bank Guarantee must be valid for one year from the date of successful commissioning of the equipment or 18 months from the date of despatch whichever is earlier. Bidder must confirm the same in their bid. **Offers not complying with this clause will be rejected.**

The validity requirement of Performance Security is assuming despatch within stipulated delivery period and confirmation to all terms and conditions of order. In case of any delay in despatch or non-confirmation to all terms and conditions of order, validity of the Performance Security is to be extended suitably as advised by OIL.

The Bank Guarantee should be allowed to be encashed at all branches within India.

- vi). Bids received after the bid closing date and time will be rejected. Similarly, modifications to bids received after the bid closing date & time will not be considered.
- vii). Validity of the bid shall be minimum 120 days from the Bid Closing Date. Bids with lesser validity will be rejected.
- viii). Bids containing incorrect statement will be rejected.
- ix). All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of

Certifying Authorities (CCA) of India. The bid signed using other than "Class 3" digital certificate, will be rejected.

# C. GENERAL:

- i) The Compliance statement must be filled up by bidders and to be submitted/uploaded along with their bids. In case bidder takes exception to any clause of the bidding document not covered under BEC/BRC, then the Company has the discretion to load or reject the offer on account of such exception if the bidder does not withdraw/modify the deviation when/as advised by Company. The loading so done by the company will be final and binding on the bidders.
- ii) If any of the clauses in the BRC contradicts with other clauses of bidding document elsewhere, then the clauses in the BRC shall prevail.

# 2.0 BID EVALUATION CRITERIA (BEC):

#### A. TECHNICAL:

The bids conforming to the technical specifications, terms and conditions stipulated in the bidding document and considered to be responsive after subjecting to Bid Rejection Criteria (BRC) will be considered for further evaluation as per the Bid Evaluation Criteria given below.

- i) In the event of computational error between unit rate and total price, the unit rate as quoted by the bidder shall prevail.
- ii) Similarly in the event of discrepancy between words and quoted figure, words will prevail.
- iii) Evaluation will be done on 'total contract cost' basis to ascertain the lowest bid.

#### **B. COMMERCIAL:**

- i) To evaluate the inter-se-ranking of the offers, Assam entry tax on purchase value will be loaded as per prevailing Govt. of Assam guidelines as applicable on bid closing date.
  - Bidders may check this with the appropriate authority while submitting their offer.
- ii) To ascertain the substantial responsiveness of the bid OIL reserves the right to ask the bidder for clarification in respect of clauses covered under BRC also and such clarifications fulfilling the BRC clauses in to must be received on or before the dead line given by the company, failing which the offer will be summarily rejected.

- iii) To ascertain the inter-se-ranking, the comparison of the responsive bids will be made as under, subject to corrections / adjustments given herein:
  - (A) Total material cost of Main Equipment:
  - (B) Total cost of tools/tackles/accessories/mandatory spares/ repair kit for commissioning
  - (C) Total Material Cost,(A+B)
  - (D) Packing and Forwarding Charges
  - (E) Total Ex-works value, (C+D) above:
  - (F) Excise Duty including Cess
  - (G) Sales Tax, (Please indicate applicable rate of Tax)
  - (H) Total FOR Despatching station price, (E+F+G) above
  - (I) Road Transportation charges to Duliajan
  - (J) Insurance Charges @0.5% of Total For Despatching StationValue (H) above
  - (K) Assam Entry Tax
  - (L) Grand Total FOR Duliajan value, (H+I+J+K) above

# **Standard Notes:**

Bid without original Bid Security will be rejected (except for the bidders who has paid the same online).
