The following BRC/BEC will govern the evaluation of the bids received against this tender. Bids that do not comply with stipulated BRC/BEC in full will be treated as non responsive and such bids shall prima-facie be rejected. Bid evaluation will be done only for those bids that pass through the “Bid Rejection Criteria” as stipulated in this document.

Other terms and conditions of the enquiry shall be as per General Terms and Conditions vide MM/LOCAL/E-01/2005 for E-Procurement of Indigenous Tenders. However, if any of the Clauses of the Bid Rejection Criteria / Bid Evaluation Criteria (BRC / BEC) contradict the Clauses of the tender or MM/LOCAL/E-01/2005 elsewhere, those in the BRC / BEC shall prevail.

1.0 BID REJECTION CRITERIA (BRC): The bid shall conform generally to the specifications, terms and conditions given in this document. Notwithstanding the general conformity of the bids to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected. TECHNICAL: Bidder's Experience : i) The material shall essentially be Ferric Alum which should conform to the relevant Governing i.e. Standard: IS 299: 1989 (Reaffirmed 2006) and be suitable for use as flocculants of solids for clarification of water in Drinking Water Treatment Plants. The manufactured product should be strictly as per OIL's tender specifications provided along with the bid. ii) Bidder should preferably be a manufacturer of the product. In case the bidder is not a manufacturer, he should be an authorized representative / dealer / supplier and should enclose an authority letter from the principals along with the bid. Such authority letter should be valid for the entire period of execution of the order. iii) The manufacturer should have at least continuous 5 (five) years of manufacturing experience of the product (as on Bid Closing Date) with bulk supply records of minimum 240 MT of Ferric Alum to companies under the Government, Semi Government, Public sector undertakings or Public Limited companies within the last 5 (five) years from the Bid Closing Date.	

Documentary evidence in support of the above should be submitted along with the bid.

iv) The bidder (manufacturer/ authorized representative / dealer / supplier) should have executed at least one order of value not less than Rs.24.24 lakhs, against supply of the item during the last 5 (five) years, from the Bid Closing Date, to companies under the Government, Semi Government, Public sector undertakings or Public Limited companies. Documentary evidence in support of the above should be submitted along with the bid. For authorized representatives / dealers / suppliers, documentary evidence towards execution of order by their principals (manufacturer) shall be acceptable.

v) Bidders (manufacturer/ authorized representative / dealer / supplier) who have not supplied Ferric Alum to Oil India Limited (OIL), on earlier instances, will have to enclose a valid BIS certificate for the product along with their bid. For bidders (manufacturer/ authorized representative / dealer / supplier) already enlisted with OIL, submission of valid IS certificate shall not be necessary provided the bidder had successfully executed purchase order of Ferric Alum, in earlier occasions, which has been tested and found to be acceptable for use in our Water Treatment Plants.

2.3 In case the bidder (manufacturer/ authorized representative / dealer / supplier) who has successfully supplied the items to OIL in the past whose past performance has been satisfactory and are not in a position to submit supporting documents required for experience criteria as per 2(iii) & (iv) above, their offer will be considered provided they indicate the past supply reference indicating the order numbers and date in the bid itself.

COMMERCIAL:

i) Validity of the bid shall be minimum 90 days from the Bid Closing Date.

ii) Bid security:

The bid must be accompanied by Bid Security of Rs 97,000.00 in OIL's prescribed format as Bank Guarantee or a Cashier's cheque or Demand Draft in favour of OIL. The Bid Security may be submitted manually in sealed envelope superscribed with Tender no. and Bid Closing date to Head Materials, Materials Department, Oil India Limited, Duliajan- 786602, Assam on or before the Bid Closing Date and Time mentioned in the Tender. The Bank Guarantee towards Bid Security shall be valid for 6 months from Bid closing date. (i.e. upto 17.05.2017). iv) Performance Security:

The successful bidder shall submit Performance Security @10% of PO value within 30 days of receipt of the formal purchase order failing which OIL reserves the right to cancel the order and forfeit the Bid Security. Bidders should undertake in their bids to submit Performance Security as stated above.

The Performance Security shall be in any one of the following forms :

(a) A Bank Guarantee in the prescribed OIL’s format valid for 3(three) months beyond the Warranty period indicated in the Purchase Order /contract agreement.

(b) A Cashier's cheque or Demand Draft with validity of minimum 90 days or as per RBI’s guidelines, drawn on “Oil India Limited” and payable at Duliajan, Assam.

The Performance Security for capital nature items like plant and machinery etc. shall be valid for 12 months from the date of commissioning plus 3(three) months or 18 months from the date of shipment/despatch plus 3(three) months whichever concludes earlier.
