Sugarcane juice (fresh) is the opaque grey dark green to light yellow liquid extracted from pressed sugarcane (Saccharum officinarum and its hybrids) during primary processing in the sugarcane fields located in Assam. Being high in microbial growth promoting substances Sugarcane juice (fresh) is to be used within 3-4 days' time from extraction in the grower's fields.</p> <p>R&D Department had recently proposed a MoU project for Field implementation of In-house developed Microbially Enhanced Oil Recovery (MEOR) in Moran-Shalmari for the year 2021- 22. In order to implement the project within the timeline, timely procurement of Sugarcane juice (fresh) will be a critical step. In this regard, efforts were initiated to contact probable local vendors for procurement of authentic Sugarcane juice (fresh) keeping in view the time span required for extraction, collection and transportation of the material. However, other than Nagaon based M/s Brahmaputra Valley Aromatic Oil Industries, no such other local capable vendor is available to supply the required quantity of fresh Sugarcane juice.</p> <p>In view of above, in-principle approval was accorded by competent authority vide proposal No. R&D/30C2/978/2020 dated 31.12.2020 for procurement of fresh sugarcane juice on nomination basis from M/s Brahmaputra Valley Aromatic Oil Industries, Nagaon instead of competitive bidding.</p>
