For the year 2017,the calendar was based on the theme "Energy" as suggested by MoP&NG. and PO no. 7511446 dated 16.09.2016 was placed on M/s Exclusive Advertising Pvt Ltd for supply of 26000 numbers of the OIL calendar through normal tendering process . Corporate Office suggested some changes as advised by MoP&NG. Accordingly, an additional fly leaf was designed and incorporated, which carried a photograph of Hon'ble Prime Ministers of India with a quote. On confirmation of the design and changes from corporate office, the print order was given to the party and they printed the 26000 nos of calendars. In the meantime, Public Affairs dept. received another advice from Corporate office that MoP&NG desires that the design and content of all the six leaves of the OIL calendar has to be changed wherein each leaf has to have photographs that showcases an amalgamation of the Government as well as the Company's initiatives. Since the new designs had to be made and also edited frequently while obtaining approvals from MoP&NG, the services of M/s Exclusive Advertising Pvt Limited was sought since the party had designed and supplied the OIL calendar for 2017 through tendering process. Corporate Office was coordinating with M/s Exclusive Advertising Pvt Limited and MoP&NG on this subject. It was also advised, that the 26000 nos of OIL calendars already printed will be distributed only to OIL employees excluding employees posted in NOIDA as well as Guwahati. This implied that 6000 nos new OIL calendars need to be printed immediately so that it can be distributed to all employees and external stakeholders under OIL's offices in Guwahati and NOIDA. Keeping in perspective the urgency of the job as well the fact that M/s. Exclusive Advertising Pvt Ltd has been involved with designing of the new calendar 2017 (6000 nos) and have offered competitive rates based on the pro-rata cost of printing the 26000 No of OIL calendar 2017 ,Public Affairs Dept. forwarded a copy of the on principle approval vide letter ref. no. PA/60-41/2016 dated 17.02.2017 for placement of order on M/s Exclusive Advertising Pvt. Limited, Guwahati on nomination basis for printing of 6000 nos. of special OIL Calendar – 2017 and advised to place the order at the earliest.
