Post placement of the order, M/s TMK ME FZCO, Dubai had requested for changing their name from M/s TMK ME FZCO to M/s SPS ME FZCO stating that M/s TMK ME FZCO is rebranded as M/s SPS ME FZCO. Considering the request and after obtaining views &amp; legal opinion from corporate Legal Department on the matter, seller's name was amended to M/s SPS ME FZCO by issuing Order Amendment No. 1 dated 14.10.2023 as approved vide FD Note No. FD/RF/083 dated 10.10.2023.</p> <p>At the time of despatch of materials, on 04th April, 2024 the representatives of the supplier have visited OIL's Jodhpur Office for a discussion on complexities faced by the party on execution of this order. Further to this discussion, supplier has submitted Letter No. 1654/24 Dated 08.04.2024 (as an attachment to e-mail dated 18.04.2024) from M/s GS Trade Links LLP, Kazakhstan with a supporting letter from M/s PAO TMK, Russia</p>

							<p>(principal company of M/s TMK ME FZCO, Dubai, original supplier) requesting to change the contractor/supplier to this order to M/s GS Trade Links LLP, Kazakhstan as M/s SPS ME FZCO has been included in US sanction list amid Ukraine-Russia war and same is under liquidation in UAE.</p> <p>Based on the request submitted by the party for changing the contractor/supplier to this order to M/s GS Trade Links LLP, Kazakhstan as M/s SPS ME FZCO has been included in US sanction list and same is under liquidation in UAE, matter was taken with the Legal Department for their views and legal opinion on the matter. Legal Department opined that under these circumstances, OIL has the right to terminate the Contract and has liberty to give the Receiver or Liquidator or any other person, the option of carrying out the purchase order subject to his providing a guarantee upto an amount to be agreed upon by Purchaser for due and faithful performance of the purchase order in terms of clause 34.3. Legal Department has further opined that while exercising the right to give the PO to “Any Other Person” the Department exercising such discretion should follow proper procedure for single tender as per DOP.</p> <p>Items covered against this order i.e Vacuum Insulate Tubing (VIT) are used in OIL's Baghewala heavy oil field for the process of Cyclic Steam Stimulation (CSS) for enhancement heavy oil production from the field. Hence these are items are very essential to maintain the smooth heavy oil production from Baghewala heavy oil field. Currently, the stock of these items are NIL and user department has expressed their operational urgency for these items on several occasions. All previous supplies of VIT were supplied by M/s TMK ME FZCO, Dubai manufactured by M/s PAO TMK.</p>
