According to the regulation, the RE generators are required to appoint one Qualified Co-ordinating Agency (QCA) for each pooling station to coordinate the activities of Scheduling & Forecasting, Co-ordination with STU/SLDC for metering, data collection/transmission, communication and Undertaking of commercial settlement on behalf of generator's. In order to comply to the regulations as laid down by Hon'ble commission, OIL had appointed M/s. RE Connect Energy Solutions Private limited as QCA for its 16 MW WEPP for a period of 3 years from 01.08.2019 to 31.07.2022, vide contract No. 6113562. As per the contract, M/s. RE Connect Energy Solutions Pvt Ltd, commenced submitting schedule's to SLDC on day ahead basis. However, there were deviations in submitted and actual generation, which there by resulted in penalty on generators at Amrapur PSS, including OIL, as per clause no. 8.5 of the regulation under reference. Hence majority generators including OIL at Amrapur PSS have emphasized on view of replacing the M/s. RE Connect Energy Solutions Pvt. Ltd. as QCA and many of the generators have given their consent to CE



	(SLDC) in order to replace M/s. RE Connect Energy Solutions Pvt. Ltd. with M/s. Manikaran Analytics Ltd. as the QCA because of considerable difference between DSM Penalty per MW.
	It may also be noted that the prices offered by M/s MAL for Forecasting and Scheduling services towards OIL's 16 MW WEPP have been compared with ongoing contract no. 6113562 on M/s RE Connect Energy Solutions Pvt Ltd The prices offered by the M/s MAL are found equal to prices of M/s RE Connect.
