With reference to the above-mentioned Tender No. GEM/2026/B/7156921, it is to note that subsequent to the GeM Run L1 selection conducted on the GeM portal, M/s Rudra Enterprise emerged as the selected GeM L1 bidder for award of Schedule-I. Further, through draw of lots, M/s Ratul Borthakur and M/s Dutta & Co. were selected for award of Schedule-II and Schedule-III, respectively, in line with the tender provisions.

However, against Schedule-I, M/s Rudra Enterprise, who had been selected through draw of lots on the GeM platform, subsequently withdrew their offer. In order to fill the resultant vacancy, an opportunity was extended to the next eligible bidder in order of priority, i.e., M/s Ratul Borthakur, to consider award of Schedule-I in place of Schedule-II.

Upon acceptance of Schedule-I by M/s Ratul Borthakur, opportunity was extended to the next eligible bidder in order of priority, i.e., M/s Dutta & Co., for award of Schedule-II in place of Schedule-III. Accordingly, M/s Dutta & Co. has also accepted the award of Schedule-II.


In view of the above, a draw of lots shall be conducted on **04.05.2026 at 14:30 HRS (IST)** at the office premises of the Contracts Department, Duliajan, Assam – 786602, in line with the tender terms and conditions, to select the bidder for award of Schedule-III from among the next eligible MSE L1 bidders, i.e., M/s P Phukan & Co. and M/s Armed Management Services.

Further, during the draw of lots, a priority list shall also be prepared to address any future vacancy in Schedule-III against GeM Tender No. GEM/2026/B/7264242.

2.0 Contracts/schedules shall be awarded to the L1 MSE bidder(s) as per BEC/PQC Clause No. 9.0 of the tender (as mentioned above).
