

This is for general information to all concerned that the following rules will be applicable for the above noted Draw of Lots (Lottery):

1.0 The allotted '**Lottery Numbers**' for the Draw of lots are enclosed as **Annexure-I & II**.

2.0 **Draw of Lots No. I cum GeM's Run L1 selection I:**

(i) LOTTERY NUMBERS have been allotted to each bidder based upon the Sl Number shown in GeM as on date within the range '**01 to 03**'. In this regard, it may be noted that the selection for '**Schedule 01**' shall be carried out first in accordance with the General Terms and Conditions (GTC) of GeM i.e. based on GeM's Run L1-based selection as clearly mentioned in Para 9.3 of BEC/PQC of the subject tender. Accordingly, the bidder who has been selected by GeM for Schedule-01 via L1-based selection, shall not be considered for the Draw of Lots (to be conducted outside GeM) for awarding the remaining schedules. Therefore, draw of Lots (outside GeM) shall be conducted among the remaining original L1 MSE bidders for the remaining next Schedules 02 & 03 (two schedules) in line with the tender terms & conditions.

(ii) There will be only **1 (One)** tombola cage. The number drawn will be recorded and a "**Priority Number**" shall be assigned accordingly.
