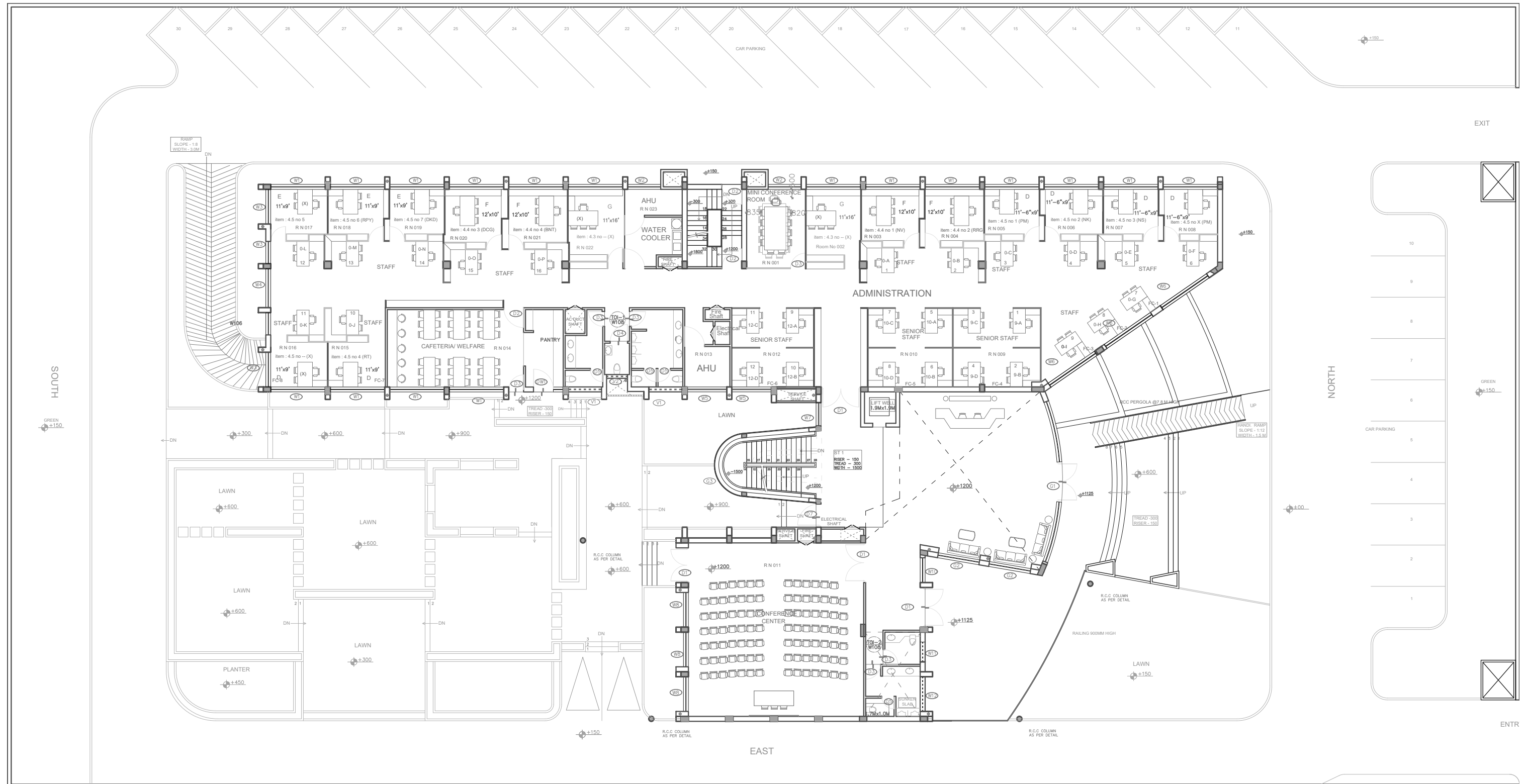

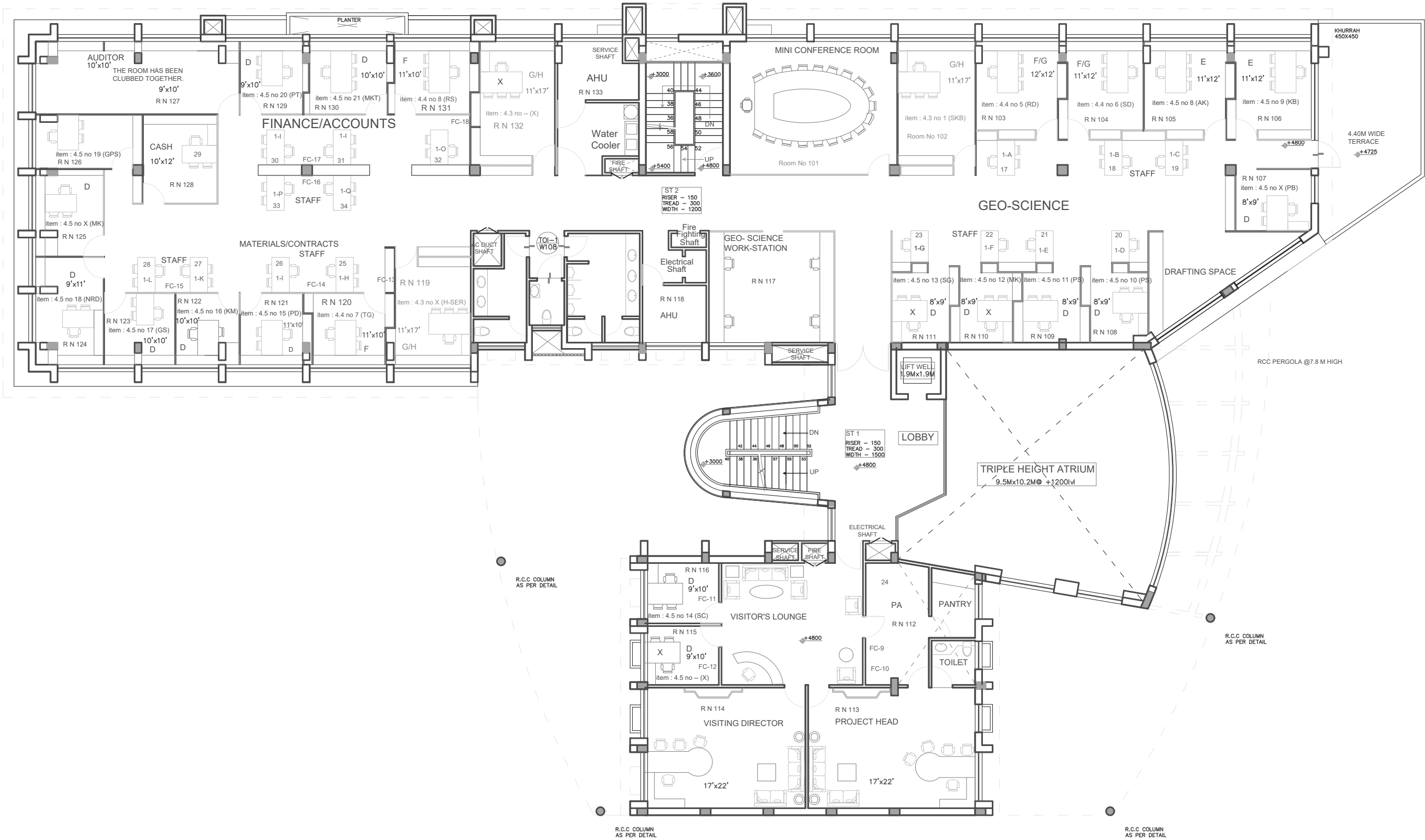

The floor plan illustrates a complex building layout with the following key areas and features:

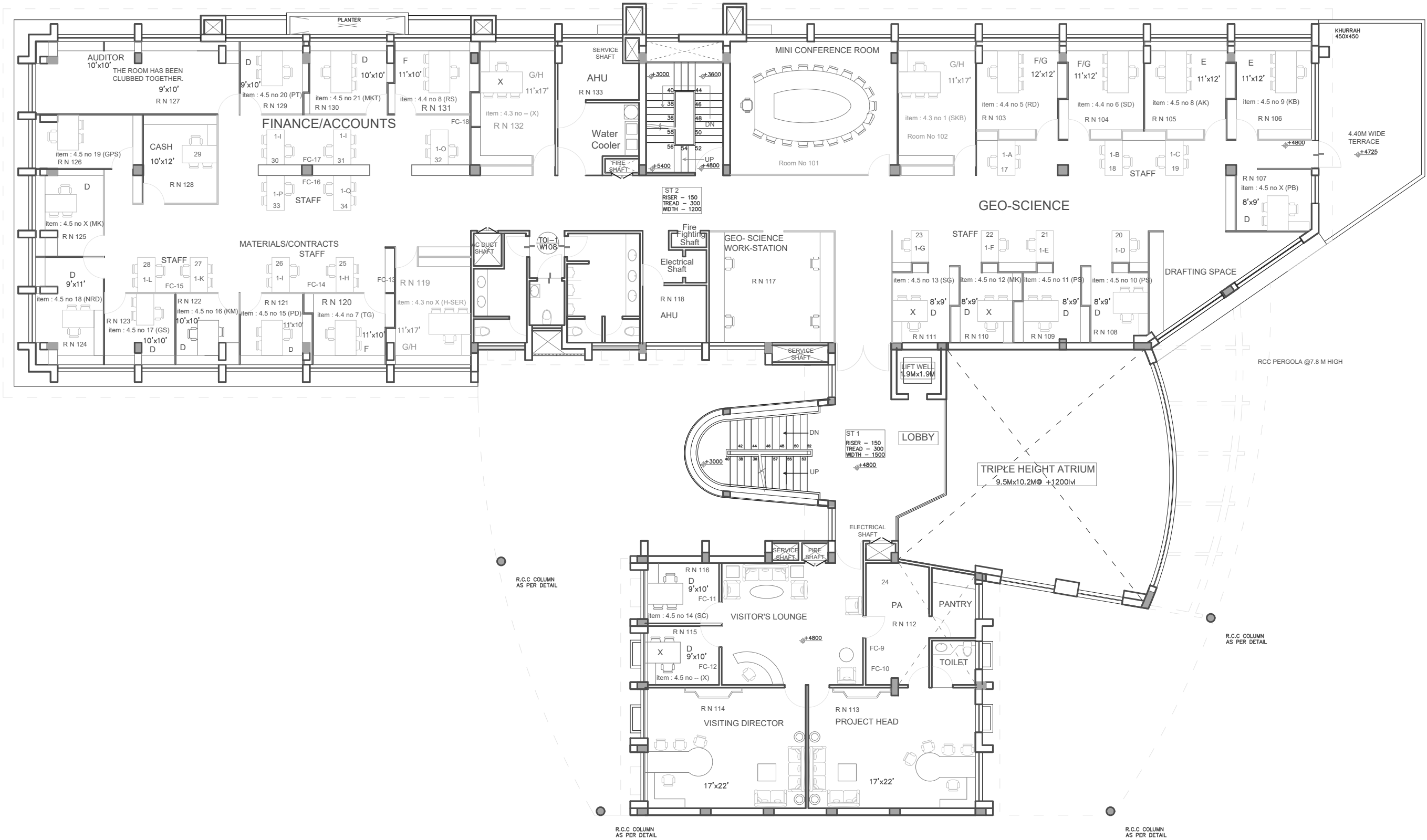
