ट्रेड्स भुगतान संबंधी विवरण/TReDS Payment Details

This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. For MSME sellers, payments may be processed through a TReDS exchange in which the Buyer is registered, subject to applicable policy and regulatory guidelines. Accordingly, sellers intending to avail payment through TReDS are required to be registered with at least one TReDS exchange in which the buyer is registered.

1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.0 The bidder shall be an Original Equipment Manufacturer (OEM)/ an authorized dealer/ authorized distributor/ Supply House of Original Equipment Manufacturer (OEM) of the tendered item(s). In case of an authorized dealer/ authorized distributor/ Supply House of Original Equipment Manufacturer (OEM) of the tendered item(s); the bidder must submit a valid copy of authorization letter/ dealership certificate (valid at the time of bidding and till entire execution of the order) with proper guarantee/ warranty back up for the quoted products from the original manufacturer (OEM) shall be submitted along with technical bid.

2.0 The bidder shall confirm in their technical bid about compliance of all the points under technical specification. All the cost towards the supply shall be included by the bidder in their prices. No additional charges shall be paid other than the offered with original offer.

3.0 Bidders shall submit related technical brochures/ specifications/ Product Catalogue/ Detailed drawing etc. of the offered items along with the bids failing which offer would not be accepted.

4.0 WARRANTY/GUARANTEE: The bidder shall confirm that materials to be supplied shall be new, of recent make, of the best quality & workmanship and shall be guaranteed by the Seller for a period of 12 months from the date of receipt at destination against defects arising from faulty materials, workmanship or design. Defective goods/ materials or parts notified by OIL to the Seller shall be replaced immediately by the Seller on F.O.R destination basis including payment of all taxes and duties at Seller's expense. This guarantee shall survive and hold good notwithstanding inspection, payment for and acceptance of the goods.

5.0 The valves must be supplied along with suitable companion matching flanges (02 nos for each valve), bolts and nuts.

6.0 The companion matching flanges must be forged steel, class 150 as per ANSI B 16.5, material as per ASTM: A 105.

7.0 No drawing(s) of bidder/ supplier w.r.t. the design of the valves shall be approved/ certified by OIL, since the onus of designing, manufacturing and supplying of the valves as per the specifications of this NIT lies solely on the bidder/ supplier.

8.0 Both seats and both sides of wedge should be cleaned, dried and greased properly after inspection/ hydraulic testing to prevent corrosion. Both ends of each valve should also be provided with protective rubber caps.

9.0 Following certificates in the relevant API 600 standard should be submitted along with the final supply:

- i. Manufacturer's Test Certificate (MTC / Mill Test Certificate)
- ii. Hydrostatic & Seat Leakage Test Certificate
- iii. Dimensional Inspection Certificate
- iv. Compliance/ Conformance Certificate
- v. Warranty Certificate (Minimum warranty period should be 24 months)

10.0 PAINTING AND MARKING:

- i. The valve should be provided with suitable anti-corrosive paint.
- ii. All valves shall be marked as per API 600.
- iii. Valve ends shall be suitably protected to avoid any damage during transit or storage. All threaded and machined surface subject to corrosion shall be well protected by a coat of grease or other suitable material. All valves shall be provided with suitable protectors, for flange faces of the valves.
- iv. Packing and shipping instructions shall be as per API 600.
- v. Each package shall be legibly marked with suitable marking ink indicating the order number, manufacturer's name, and valve size with pressure rating.

11.0 Valve shall be suitable for either buried or above ground installation.

12.0 All the valves of similar type, size and pressure rating will have same casting pattern & bonnet design.

13.0 Height of all the valves of similar type, size and pressure rating will be same in order to maintain uniformity.

14.0 DESPATCH:

- a) The valves shall be completely assembled, tested, cleaned, dried, and kept in fully closed position before dispatch, and both seats and both sides of the wedge shall be properly cleaned and protected with suitable rust preventive oil/grease.
- b) The valve ends shall be adequately protected with suitable end caps to prevent ingress of dust, moisture, or foreign material during handling, transportation, and storage.
- c) The valves shall be securely packed in wooden crates or equivalent robust packing, suitable to withstand rough handling, long-distance transportation, and storage at site without any damage.
- d) Each package shall be legibly marked with suitable marking ink indicating the Purchase Order number, Manufacturer's name, Valve size, and Pressure rating.
- e) The vendor shall ensure that all mandatory inspection, test, and warranty certificates, as specified in Clause 9.0, are dispatched along with the material.
- f) Any damage arising due to improper packing, inadequate protection, or handling during transit shall be the sole responsibility of the contractor, and replacement shall be arranged at no extra cost to the owner.
- g) Dispatch of the valves shall be carried out only after clearance by OIL, in accordance with the terms of the Purchase Order.
- h) The entire supply of valves shall be completed within **two months** from the date of issue of the Purchase Order.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel

the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate

action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
