6. **Purchase Preference (Centre)**

The minimum local content to qualify as a class 1 local supplier is denoted in the bid document 50%. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

7. Floating / creation of work contracts as Custom Bids in Services.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
