1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

3. Scope of Supply

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Buyer Added Bid Specific ATC

1.0 Financing of trade receivables of Micro and Small Enterprises (MSEs) through Trade Receivables Discounting System (TReDS) platform.

Based on the initiatives of the Government of India to help MSE vendors get immediate access to liquid funds based on Buyers' credit rating by discounting, OIL has registered itself on the TReDS platform with M/s R XIL, M/s A TREDS Ltd. (Invoice Mart), M1xchange, C2treds, and DTX. MSE vendors can avail this benefit by r

registering themselves with any of the exchanges providing e-discounting / electronic factoring services on the TReDS platform and following the procedures defined therein, provided OIL is also participating in such TReDS Platform as a Buyer.

(i) Vendor should be aware that all costs relating to availing the facility of discounting on the TReDS platform, including but not limited to Registration charges, Transaction charges for financing, Discounting Charges, Interest on financing, or any other charges known by any name, shall be borne by the MSE Vendor.

(ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its affiliates, Directors, officers, representatives, agents and employees indemnified, from any and all damages, losses, claims and liabilities (including legal costs) which may arise from Sellers submission, posting or display, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.

Note:

(i) Buyer means OIL, who has placed a Purchase Order / Contract on a MSE Vendor (Seller).

(ii) Seller means a MSE vendor who has been awarded a Purchase Order / Contract by OIL, (Buyer).

2.0 “FORWARDING LETTER & INSTRUCTION TO BIDDERS”, “GENERAL CONDITIONS OF CONTRACT”, “SPECIAL CONDITIONS OF CONTRACT”, “ALL ANNEXURES & PROFORMAS”, “BEC/BRC”, etc., attached in "Buyer Added Bid Specific ATC" tab. Bidders shall have to upload duly filled-up Annexures and Proformas along with documentary evidence in support of the evaluation criteria and item specifications as per the tender, along with the technical bid.

3.0 If any of the specifications/ clauses mentioned in the body of the tender document contradict those mentioned in the document uploaded under “Buyer added bid specific ATC”, the specifications/ clauses mentioned in “Buyer added bid specific ATC” shall prevail.

4.0 Bidders are advised to submit their queries, if any, within 15 days from the date of tender publication. OIL shall not be liable to respond to any queries received after the stipulated deadline.

5.0 The items covered in this Tender shall be used by Oil India Limited in the Petroleum Exploration License (PEL) and Mining Lease (ML) areas, and hence concessional GST @12% will be applicable as per the Government Policy in vogue.

Note: Successful bidder shall arrange to provide all necessary documents (invoice, etc.) to OIL for applying for the essentiality Certificate on receipt of request from OIL or at least 45 days prior to their readiness for dispatch, whichever is earlier. Further, the successful bidder shall affect dispatch only on receipt of relevant certificates/shipment clearance from OIL, failing which all related liabilities shall be to the supplier's account.

6.0 Bidder must confirm the following while quoting:

6.1 The ropes shall be manufactured as per IS-1084:2005 specifications.

6.2 The evenly spun 4.6 ktex yarn throughout the length processed on the Hard Fibre Processing Plant shall be used for the manufacture of the ropes. Hard hackled or hand-spun yarn shall not be used.

6.3 The ropes shall be well laid & free from defects. Each coil shall be continuous throughout its length & shall not contain loose ends, splices, or joints in strands or in the rope.

6.4 The ropes shall be supplied in coils duly packed as per IS-3256 specifications.

6.5 The length of rope in each coil should be 220 Mtrs.

6.6 The maximum permissible variations in length of each coil under zero tension shall be restricted to the ranges specified below:

- a) Rope Diameter up to 14 mm diameter - Tolerance +/- 5%
- b) Rope Diameter above 14 mm diameter - Tolerance +/- 3%

6.7 The Mass of each coil & tolerance thereof should be as per Clause 8.1 of IS-1084:2005 specifications.

6.8 Each coil shall have at both ends labels securely attached on which the following shall be marked:

- a) Manufacturer's name & /or trademark
- b) Length of rope in the coil
- c) Diameter of rope in mm
- d) Month & Year of Manufacture
- e) Grade
- f) Purchase order number

6.9 Each coil shall also be marked with the BIS Certification Marking / "ISI" mark as per Clause 12.2 of IS-1084:2005 specifications.

6.10 Rope should be rot-proofed by application of a suitable rot-proofing agent throughout the length as per Clause 6.6 of IS-1084:2005 specifications.

7.0 Bidders must submit a copy of a valid IS-1084:2005 certificate (license to use ISI Standard Mark) along with the bid.

8.0 A valid test certificate from the National Test House (Govt. of India) for the ordered batch as per the IS norms has to be provided along with the consignment. The bidder has to confirm their acceptance categorically in their offer for the tendered sizes of ropes on the same.

9.0 Supply houses / authorized representative/dealer/supplier submitting an offer against this tender should submit the following, along with their bid:

- a) Letter of Authorization from the manufacturer whose product they are offering.
- b) Copy of a valid IS-1084:2005 certificate (license to use ISI Standard Mark) of the manufacturer whose product they are offering.

7. **Generic**

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
