If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

1) Queries Submission Timeline clause-

All prospective bidders are hereby instructed to submit any queries or requests for clarification related to this tender within a period of five (5) calendar days from the date of publishing of this tender document. Any queries received after the stipulated deadline will not be entertained or responded to by OIL. Queries must be submitted in writing via email to Swarup_majumder@oilindia.in. Please ensure that the subject line of your email clearly states, "Tender Query & GEM Bid No.".

2) **Payment Timelines:** Payments shall be made to the Seller within 21 days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills (This is in supersession of 10 days' time as provided in clause 12 of GeM GTC).

3) The bidders are required to submit EMD against this GEM Bid.

4) Bidders are requested to submit all the Proformas as per the requirement of the GEM bid.

5) The same or similar category of products as mentioned in experience criteria means " Water Filtration Plant of capacity not less than 20 KL/HR with components like Multi Grade Filter/Iron removal filter".

6) PBG should be valid for 24 (Twenty-Four) months from the date of issue. PBG validity less than the above-mentioned period will have to be amended by the seller.

7) **PRE-DESPATCH INSPECTION:** OIL's engineer (including members from Materials Department) shall inspect the Filtration plant as a whole at manufacturer's work prior to dispatch.
