Brief Description of the Approval Granted by Competent Authority	This is to certify that Oil India Limited is a Central Public Sector Enterprises under the Ministry of Petroleum and Natural Gas (MOPNG) and are engaged in oil & gas exploration and production activities. Oil India Limited has adopted Purchase Preference policy linked with Local Content issued by MOPNG vide notification no. FP-20013/2/2017-FP-PNG dated 17.11.2020 and the original policy was approved by the Cabinet. This policy is applicable for tender value more than Rs. 1 Crore to treat the local supplier as Class I, Class II and Non Local Supplier and to extend the benefit of purchase preference accordingly as per policy. Since, the estimated value of the subject tender is less than Rs. 1 Crore, no Purchase Preference Policy shall be applicable against this tender.

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**2. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**3. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

**1.0 Financing of trade receivables of Micro and Small Enterprises (MSEs) through Trade Receivables Discounting System (TReDS) platform.**

Based on the initiatives of Government of India to help MSE vendors get immediate access to liquid fund based on Buyers credit rating by discounting, OIL has registered itself on TReDS platform with M/s RXII, and M/s A TReDS Ltd. (Invoice Mart). MSE vendors can avail this benefit by registering themselves with any of the exchanges providing e-discounting / electronic factoring services on TReDS platform and following the procedures defined therein, provided OIL is also participating in such TReDS Platform as a Buyer.

(i) Vendor should be aware that all costs relating to availing the facility of discounting on TReDS platform including but not limited to Registration charges, Transaction charges for financing, Discounting Charges, Interest on financing, or any other charges known by any name shall be borne by MSE Vendor.

(ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its affiliates, Directors, officers, representatives, agents and employees indemnified, from any and all damages, losses, claims and liabilities (including legal costs) which may arise from Sellers submission, posting or display, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the terms

ms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.

Note:

(i) Buyer means OIL, who has placed Purchase Order / Contract on a MSE Vendor (Seller).

(ii) Seller means a MSE vendor, who has been awarded Purchase Order / Contract by OIL, (Buyer).

2.0 **"Statement of Non-Compliance (Annexure-AA)", "Commercial Check List (Annexure-BB)", "Undertaking of authenticity of information/documents submitted (Annexure-K)"** attached in "Buyer Added Specific ATC" tab. Bidder shall have to upload the duly filled up Annexures with seal and sign along with the technical bid.

3.0 Bidder must be OEM or authorized dealer of OEM. Bidders other than OEM must provide the letter/certificate of authorization from OEM as their Authorized Dealer at the time of bid submission. Otherwise, the offer will be liable for rejection.

#### **4.0 The offered Industrial Safety Helmet must have following features:**

1. Standard: IS 2925 with latest amendments

2. Size of the helmet (520 mm to 600 mm)

3. Shell of the helmet must have following features:

i. Type - Helmet with peak

ii. It should be dome-shaped moulded out of high-quality HDPE / Polypropylene.

iii. It must possess penetration resistance, flammability resistance, electrical resistance, heat resistance, shock absorption resistance and water absorption as per IS 2925.

iv. No metallic components shall be used in the shell

v. Colour - Yellow

vi. Minimum 3 Nos. ventilation holes on top portion of each side (Diameter of hole - 3 mm)

vii. Brim shall be designed to prevent falling water straight downward in case of rain and give protection to face

4. Headband of the helmet must have following features:

i. The headband shall be made of high-quality LDPE

ii. The width of the headband shall not be less than 30 mm

iii. The width of the cradle strap shall not be less than 19 mm.

iv. The headband shall be fitted with anti-concussion tapes made of sponge with perforated backing for ventilation and absorption of sweat secure at least at 4 anchoring points.

v. It must include a rotatable ratchet knob for adjusting the size

5. Chin strap of the helmet must have following features:

i. It shall be attached to the shell

ii. The width of the chin strap shall not be less than 25 mm.

iii. It shall be permanently fitted with a fastening device to adjust and maintain tension

6. Special Requirements:

- i. Nape strap shall be an integral part or as an attachment to the headband.
- ii. Mass of the helmet without attachments must be 400 grams
- iii. No metal parts shall be used in the helmet

7. Markings required on inner side of helmet shell:

a) On inner side of helmet shell

- i. Clearly visible BIS logo should be embossed
- ii. Manufacturer's name and trade-mark
- iii. Size of helmet

b) On outer side of helmet shell

- i. OIL logo in bi-colour (black & red) should be embossed/screen printed on the front side of the helmet.

**5.0 Special terms and conditions:**

1. The bidder must submit technical literature/ catalogue of the offered product.
2. The bidder must be BIS licensed manufacturer or Authorized dealer of BIS licensed manufacturer. In case of Authorized dealer, an authorization certificate from OEM to sell the product to be submitted along with the bid.
3. The copy of the valid BIS license of the manufacturer for IS 2925 must be submitted along with the offer.
4. Guarantee/ Warranty certificate for one year from the date of delivery acceptance will be required along with the supply.
5. In the event of an order being placed on a bidder, the bidder shall submit sample of at least 01 (one) no. within 14 days from the date of PO.
6. Bulk supply to be made only after receipt of successful sample approval from OIL.

6.0 If any of the specifications/ clauses mentioned in the body of the tender document contradict with that mentioned in the document uploaded under "Buyer added bid specific ATC", the specifications/ clauses mentioned in "Buyer added bid specific ATC" shall prevail.

7.0 Bidders are advised to submit their queries, if any, within 15 days from the date of tender publication. OIL shall not be liable to respond to any queries received after the stipulated deadline.

4. Creating BoQ bid for single item.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
