The process got affected due to cancellation of the previous tender for construction of ETP on BOO basis floated in 2014 (no acceptable offer received against the Global tender) where M/s EIL was engaged as the consultant. EIL has already carried out all the background work and they are aware of the market availability of the best technology and has also prepared the tender for the ETP on BOO basis. Therefore, floating of the tender on EPC/ LSTK basis can be executed in a very short time by EIL by changing the execution philosophy from BOO to EPC / LSTK basis. After series of negotiation with M/s EIL on their fresh proposal, M/s EIL was recommended on nomination basis as a consultant for the construction of ETP at Tengakhat on EPC/LSTK mode under new EPMC Contract Service. | 341 (a) |
