The Draw of Lots (DOL) against the Tender No. CDC8833L22 & CDC0004L22 was conducted on 11.01.2022 & 16.06.2022 respectively to select three (3) numbers of bidders priority-wise for technical scrutiny of bids. However, none of the three (3) bidders selected in DOL were found to be technically qualified as per BEC/BRC of the tender.

2.0 Hence, DOL was conducted on 14.07.2022 to select 7 bidders again among the remaining 15 & 38 bidders for further scrutiny for Tender No. CDC8833L22 & CDC0004L22 respectively. But, the 7 selected bidders were not found to be technically qualified.

3.0 Since, not a single bidder could be ascertained as technically qualified even after conducting two consecutive DOLs, it has been decided to select all the remaining 8 & 31 bidders for Tender No. CDC8833L22 & CDC0004L22 respectively, priority wise at one go in the next DOL and conduct technical scrutiny of all such bidders in that order.

4.0 Therefore, the final DOL shall be conducted on **16.08.2022 at 01:30 p.m. (IST) in Contracts Department, OIL India Limited, Duliajan.**

5.0 The eligible bidders or their authorised representatives other than the 10 bidders selected earlier are hereby advised to attend the office of **GM-Contracts (HOD)** on the date and time as fixed above to participate in DOL.
